### What We Do

The West Virginia Alcohol Beverage Control Administration (WVABCA) in partnership with State Farm®, and the West Virginia Governor's Highway Safety Program (GHSP) purchased and developed a DUI Simulator Program to combat underage drinking and educate youth about the dangers of drinking and driving and distracted driving. The simulator allows the driver to experience:

- Effects of different Blood Alcohol Contents (BAC) levels while operating a vehicle.
- Real life situations while driving under simulated levels of intoxication.

# Site Requirements

Site requirements for an event are relatively easy to meet. The DUI Simulator coordinator will visit your location to help assure that site needs are available. Requirements include:

- A parking space 36ft x 15ft as close as possible to the participating audience.
- Two 110 power outlets on separate breakers . (Generator in Simulator truck can be used if needed)
- An audience consisting of predominantly licensed drivers 15-20 years of age. Adult populations are also welcome.

#### **Our story**

Since the kick-off of the program in the fall of 2010, the DUI Simulator has visited every high school in the state. We have also visited many colleges, universities, and attended special events. As of January 1, 2016, the WVABCA has had nearly 30,000 people to participate in the program. The DUI Simulator Program places an emphasis on encouraging youth and the public to make good decisions.

# WVABCA Public Service Announcement Contest

The Annual "NO School Spirits" PSA contest complements the DUI Simulator program by encouraging high school students to submit video or essay entries addressing the dangers of drinking and driving or underage alcohol use. Funding is provided by State Farm®, NABCA, GHSP, and WVABCA. Prizes range from \$5000-\$1000 and must be used for school equipment or programs. The winning school will take part in creating a PSA that will air statewide.
