**INSTRUCTIONS**

All questions and/or descriptions must be answered. The application must be signed and notarized. If any questions/description cannot be completed in the available space on the application, please submit additional pages as needed. Each additional page submitted must include entity name, DBA name, and indicate which question applicant is answering.

**Applications must be made at least 15 days prior to the event. Failure to adhere to submission requirements may result in application not being processed.**

Applications must be completed correctly and all necessary paperwork included when mailed to the ABCA. Failure to do so will result in the application being delayed and/or returned to the applicant for the necessary corrections.

Applicant must indicate whether: (1) Beer; (2) Wine; (3) Beer and Wine; or (4) Beer, Wine and Liquor will be sold at the event. (See box at the top right on the first page of the application form – ABCA-192F&F)

Applicant is required to notify, in writing, all distributors and resident brewers (acting in a limited capacity as a distributor of their own products from the place of manufacture) in the area where the fair, festival, or special event will occur providing them the opportunity to participate. A list of all licensed distributors and resident brewers is provided with the application packet.

Wine must be purchased from a WV licensed wine distributor, WV licensed farm winery or WV licensed multi-capacity winery.

Liquor must be purchased from a WV licensed liquor store located in the market zone where the "Special Event" is being held or in a contiguous market zone.

No alcohol may be donated or auctioned at any special event, fair and festival or private fair and festival.

The event holder must use bona fide employees or volunteers to sell, furnish, tender or serve alcohol.

Licensed Distributors, Brewers, Resident Brewers, Wine Distributors, Wine Suppliers, Brokers and Reps may attend and discuss their respective products at the event but shall not sell, furnish, tender or serve any alcohol or otherwise be involved with the event. In certain instances, these licensees may sell sealed containers for off-premises consumption and offer complimentary samples at a Private Fair and Festival (See additional information on “Special Events FAQ Sheet”).

\*All equipment provided by a manufacturer, resident brewer, distributor, or reps must be rented.

LICENSE FEES – License fees must be paid by Certified Check, Cashier’s Check, or Money Order. Personal Checks, business checks, or cash will not be accepted. Make checks payable to the West Virginia ABCA.

LIVE SCAN FINGERPRINTING – All applicant must complete a Live Scan Fingerprint in order to obtain a valid license. IdentiGO by Morpho Trust will provide fingerprinting services for all WVABCA license applicants. Contact IdentiGO at 855-766-7746 or online at L1enrollment.com for information on fingerprinting, locations, scheduling appointments, and fee requirements. No finger printing is necessary if the applicant currently holds an active WVABCA license.

Please contact the WVABCA Licensing Department at 304-356-5500 to obtain the proper service code for the Live Scan Fingerprinting process.

Fingerprint result reports **MUST** be sent to WVABCA directly from Morpho Trust (L-1).

**NO REPORTS WILL BE ACCEPTED DIRECTLY FROM LICENSE APPLICANTS.**

HEALTH PERMIT – Applicants must provide a copy of a valid Health Permit issued in applicant’s name. (If Association, Limited Liability Company, or Corporation, the Health Permit must be issued in the business entity name and list the DBA name.)

LOCATION- The applicant must provide a map/drawing/floor plan of the area in which alcoholic beverages are to be served and consumed at the fair or festival. The applicant should indicate where security and “No Alcohol Beyond This Point” signage will be located on the floor plan.

SPONSORSHIP – The fair or festival must be sponsored or endorsed by the governing body of either the municipality or of the county wherein the fair or festival is to be conducted. The applicant must provide a letter from the governing body stating the dates and times of the event has been approved to be held. If multi-vendor, sponsorship letter must list each approved multi-vendor.

Please also provide a list of any entities paying for sponsorship of the event.

LICENSEE- A licensee is authorized to utilize bona fide employees or volunteers to sell, furnish, tender, or serve the nonintoxicating beer, nonintoxicating craft beer, wine or liquor. Persons that do not fall under one of the said categories may not be involved in selling, furnishing, tendering, or serving.

**INSTRUCTIONS FOR SIGNING:**

- a.) If an individual, by the owner.
- b.) If a partnership, by each member of the partnership (Copy of Partnership Agreement to be submitted to WVABCA).
- c.) If an association, by each member of the governing board.
- d.) If a corporation, by all officers, or by other persons specifically authorized by corporate resolution (copy of resolution must be enclosed).
- e.) If a limited liability company, by all members.
- f.) Manager(s) must sign.

\*All applying entities must be in good stand with WV Tax Dept (all multi-vendor entities must qualify).

\*Persons listed on the application must match WV Secretary of State filings.

They may <u>not</u> sell sealed bottles of liquor for off premises or on premises consumption nor offer samples.</p>	<p>Distilleries can attend the event. They may sell sealed bottles of liquor for off-premises consumption, offer complimentary samples and sell samples of liquor.</p> <p>Samples cannot exceed 6 oz per person per day and can be straight liquor or include nonalcoholic mixers. For example, three 2 oz samples of liquor that may contain a nonalcoholic mixer in addition to the liquor volume, one sample made by mixing 2 separate 3 ounce pours of the same or different liquors, one 6 ounce sample of straight liquor, two 3 ounce samples of liquor straight, or two 3 ounce samples with 1.5 oz of 2 different liquors per sample.</p> <p>Liquor may be sold by the drink or glass, for on premises consumption. It is required that Special Event License holders notify ALL local area beer distributors and resident brewers in order to provide them with the opportunity to participate in the Special Event.

Beer Distributors and Resident Brewers may not be involved in sales, furnishing, tendering or serving at the special event. Participation in the event may not be contingent upon sponsorship.
